**BACK-UP POLICY.** TSR will provide you with a back-up of the Program upon receipt of your completed Warranty Registration Card and payment of TSR's then current applicable back-up copy fee.

**RESTRICTIONS ON USE AND TRANSFER.** The original and any back-up copies of the Program and its documentation are only to be used in connection with a single computer.
