SoftKey License Agreement

This agreement governs your use of the SoftKey products enclosed with it including any manuals, disks, computer program and materials associated with it (the "Software").

Install Instructions for REALMS™ OF ARKANIA

To install Blade of Destiny onto your hard disk:

1. Insert the Program CD into your CD-ROM drive.
2. At the DOS prompt, change your CD-ROM drive by typing the letter followed by a colon and press Enter. For example, **D:** [Enter], where D is the CD-ROM drive letter.
3. Type **INSTALL** [Enter]. Use the TAB key to move between the on-screen options and ENTER to select.

To run Blade of Destiny:

1. Type **CD\BLADE** [Enter] to change to the program directory on your hard drive.
2. Type **BLADE** to start the program.

To view the manual, follow step 2 of the install to change to the CD-ROM drive. Type **README** and press Enter.
